Since United States citizenship was offered to my people (American Indians) and citizenship of the United States in this case is a new country for the Indian to move to. We shall call this citizenship for the Indian, "a promise". Now this promise to the Indian, presented in a legal manner which the American Indian assumed to be a legal citizen of the United States, which in turn, the Government of the United States assumed it could enact laws that would terminate Indian Sovereign lands and countries, by getting these Indians to accept a type of government to manage Indian tribal affairs and rule over members of these sovereign nations by a system of Government that was foreign and not the type of Government, the United States found when making their treatles with these Indian Nations. Those types of Government, presented to those Indian Nations are in direct conflict to the interests and protection of the Indian that has and still is faithful to his Indian Nation, while the Indian that assumes he is a legal citizen of the United States, assimilates to the major counties and cities of the United States, forgot to take this Government with him. These types of government, written from the concept of International Law, are for people or physical beings that are classified as, having dual or multiple nationalities, or Inhabitants of a ceded or conquered territories to have citizenship and constitution written and approved by the Congress of the United States, which was done, meeting the conditions of the Treaties of FLORIDA, LOUISIANA, GUADALUPE HIDALGO, (sometimes referred to as the Treaty of Queretaro, or the Treaty of New Mexico) and of course, the Treaty of ALASKA. These physical beings are not necessarily conquered, but in the territory that was conquered because of wars between countries that follow European concepts, which is for European or European descent only.

When the Indian leaves the protection of the reservation, this does not mean that he is an Inhabitant of a ceded or conquered territory, but exercising his right of OCCUPANCY, which cannot be changed, altered, or set aside because the American Indian has and did win the conflicts between European groups or members, where treatles were signed that gave identity to these groups of European descent, as a nation for the first time.
