To prove that American Indians are citizens of the United States, the burden of proof is on the White Man (1925, 34 Op.Atty.Gen.439, 25U.S.C.194,) and the White Man here can be defined as his court system or any of the various functions that have authority in the United States. It shall be the responsibility of all courts at all levels to produce the following:

- 1. Certificate of Tribal Abandonment, which must have with it, a written request for this certificate, date and names and places that removed this Indian's name from all tribal activities and recognition, and what happened to all property of this Indian, including the names of persons that requested his property (REAL, UNREAL, of INTERESTS THEREIN) which is the beginning reason for this certificate.
- Certificate of Competency. Copy of the Indian's grade and the standard requirement that is passing, date and place of test, and the judges of his grade.
- -3. Certificate of Eligibility. The place and date this certificate was used to purchase vacant land, and the date the land title was placed in the hands of the Secretary of the Interior, so that the 25 years which this Indian must wait so that a Bill can be presented to Congress relieving Guardianship, Alienation, and Severalty.
